REPRIMAND

Under the Rules for Enforcement of Lawyer Conduct promulgated by the Supreme Court of the State of Washington, you have been directed to receive this FORMAL REPRIMAND.

Between April 2012 and February 2013, you failed to maintain IOLTA account records as required by the RPC's and you disbursed funds for clients before funds were deposited into trust for those clients. Because of your inadequate records, some deposits and disbursements during that time period could not be identified by client.

Your conduct in failing to maintain IOLTA account records violated RPC 1.15A(c)(3) and 1.15B. Your conduct in disbursing funds from your IOLTA account before funds were deposited into trust for those clients violated RPC 1.15A(h)(8).

1 These actions merit a Formal Reprimand. Your actions discredit you and the legal
2 profession and show a disregard for the high traditions of honor expected from a member of the
3 Association.

4 NOW, THEREFORE, YOU ARE HEREBY REPRIMANDED by the Washington State
5 Bar Association for this misconduct. This Reprimand will be made a part of your permanent
6 record with the Association, and will be considered along with other evidence regarding any
7 future grievances against you.

8 Your privilege to practice law in the State of Washington is based on the finding that
9 you are a person of good moral character, and on your commitment to abide by the rules
10 governing the conduct of members of the Association. The Association expects all your future
11 conduct as a lawyer to be consistent with that finding as to your character, and with a continuing
12 commitment on your part to the letter and spirit of those rules.


