From May 2010 through November 2011, you performed no work on the client's 18 case and did not respond to several requests for information. 19 3. In October 2010 and July 2011, the client requested a refund of his advanced fee. 20 You did not respond to these requests or provide an accounting to the client. 21 4. In November 2011, you refunded the client's advanced fee after he filed a grievance 22 with the Association. 23 Your conduct violated RPC 1.3, RPC 1.4(a)(3), RPC 1.4(a)(4), RPC 1.15A(e) and (f), 24

1	and RPC 1.16(d).
2	These actions merit a Formal Reprimand. Your actions discredit you and the legal
3	profession and show a disregard for the high traditions of honor expected from a member of the
4	Association.
5	NOW, THEREFORE, YOU ARE HEREBY REPRIMANDED by the Washington State
6	Bar Association for this misconduct. This Reprimand will be made a part of your permanent
7	record with the Association, and will be considered along with other evidence regarding any
8	future grievances against you.
9	Your privilege to practice law in the State of Washington is based on the finding that
10	you are a person of good moral character, and on your commitment to abide by the rules
11	governing the conduct of members of the Association. The Association expects all your future
12	conduct as a lawyer to be consistent with that finding as to your character, and with a continuing
13	commitment on your part to the letter and spirit of those rules.
