Under the Rules for Enforcement of Lawyer Conduct promulgated by the Supreme Court of the State of Washington, you have been directed to receive this FORMAL REPRIMAND.

Your conduct in failing to disclose to clients the fact and extent of your personal financial interest in continuing to receive client referrals from CLA and failing to obtain your clients' informed written consent in the face of the conflict of interest violated RPC 1.7(a)(2) and RPC 1.7(b)(4).

These actions merit a Formal Reprimand. Your actions discredit you and the legal profession and show a disregard for the high traditions of honor expected from a member of the Association.

NOW, THEREFORE, YOU ARE HEREBY REPRIMANDED by the Washington State

1 Bar Association for this misconduct. This Reprimand will be made a part of your permanent
2 record with the Association, and will be considered with other evidence regarding any future
3 grievances against you.

4 Your privilege to practice law in Washington is based on the finding that you are a
5 person of good moral character, and on your commitment to abide by the rules governing the
6 conduct of members of the Association. The Association expects all your future conduct as a
7 lawyer to be consistent with that finding as to your character, and with a continuing
8 commitment on your part to the letter and spirit of those rules.


