ORDERED:

Scott R. Peterson is suspended from the practice of law for 18 months. Pursuant to ELC 13.2, the effective date of suspension is 7 days from the date of this order. Costs and expenses, pursuant to ELC 13.9, as approved by the disciplinary board, and restitution, pursuant to ELC 13.7, as approved by the disciplinary board, will be paid by Scott R. Peterson.
