REPRIMAND

Under the Rules for Enforcement of Lawyer Conduct promulgated by the Supreme Court of the State of Washington, you have been directed to receive this FORMAL REPRIMAND.

In 2008, you were the director and sole owner of "HJ Law, Ltd." In May 2008, Hyunsik Kong approached your firm to help him obtain a "green card." At the time, you anticipated being suspended or disbarred as the result of prior disciplinary proceedings and you were in the process of leaving your law practice to start work in a non-lawyer position in the private sector. Without your knowledge, Kevin Choi, your legal assistant and office manager, met with and agreed to help Kong, executed a fee agreement with him and told him what documents would be needed for the immigration matter. Kong ultimately wrote checks totaling \$3,500 to your firm, of which \$2,500 was deposited in the firm's operating account and \$1,000 was taken by Choi. You were unaware of the representation and the payments, never met Kong, performed no

1	services for him, and did not monitor Choi's actions. After more than a year passed and Choi
2	failed to perform the services for which Kong had paid, Kong terminated the representation and
3	filed a grievance against you. Although you had had no dealings with Kong, when you learned
4	that \$2,500 of his funds had gone into the firm's operating account, you sent him a letter of
5	apology and a refund check for that amount.
6	Your conduct in failing to ensure that the conduct of Kevin Choi was compatible with
7	your own professional obligations, violated RPC 5.3(a).
8	These actions merit a Formal Reprimand. Your actions discredit you and the legal
9	profession and show a disregard for the high traditions of honor expected from a member of the
10	Association.
11	NOW, THEREFORE, YOU ARE HEREBY REPRIMANDED by the Washington State
12	Bar Association for this misconduct. This Reprimand will be made a part of your permanent
13	record with the Association, and will be considered along with other evidence regarding any
14	future grievances against you.
15	Your privilege to practice law in the State of Washington is based on the finding that
16	you are a person of good moral character, and on your commitment to abide by the rules
17	governing the conduct of members of the Association. The Association expects all your future
18	conduct as a lawyer to be consistent with that finding as to your character, and with a continuing
19	commitment on your part to the letter and spirit of those rules.
