This matter came before the Court on the Washington State Bar Association Disciplinary Board's order approving Stipulation to Disbarment pursuant to ELC 9.1(c)(2), entered into by Paul D. Jacobson and WSBA Disciplinary Counsel on May 14, 2013. The Court reviewed the order and the stipulation and determined unanimously that the following order should be entered. Now, therefore, it is

ORDERED:

Paul D. Jacobson is disbarred from the practice of law. Pursuant to ELC 13.2, the effective date of disbarment is 7 days from the date of this order. Costs and expenses, pursuant to ELC 13.9, as approved by the disciplinary board, and restitution, pursuant to ELC 13.7, as approved by the disciplinary board, will be paid by Paul D. Jacobson.
