ORDER APPROVING
STIPULATION TO DISBARMENT

This matter came before the Court on the Washington State Bar Association Disciplinary Board's order approving a Stipulation to Disbarment pursuant to ELC 9.1(c)(2), entered into by Clarence C. Jones and WSBA Disciplinary Counsel on March 22, 2013. The Court reviewed the order and the stipulation and determined unanimously that an order approving the stipulation to disbarment should be entered. Now, therefore, it is

ORDERED:

Clarence C. Jones is disbarred from the practice of law. Pursuant to ELC 13.2, the effective date of disbarment is 7 days from the date of this order. Costs and expenses, pursuant to ELC 13.9, as approved by the disciplinary board, and restitution, pursuant to ELC 13.7, as approved by the disciplinary board, will be paid by Clarence C. Jones.
