On July 17, 2012, the Supreme Court of the State of Arizona entered an Order disbaring Jonathan Abraham Elgart from the practice of law in Arizona. ELC 9.2(e) provides that a final adjudication of lawyer misconduct in another jurisdiction conclusively establishes the misconduct for purposes of a disciplinary proceeding in this state. Upon notification of the action of the Supreme Court of the State of Arizona, this court issued an order, pursuant to ELC 9.2(c), directing Jonathan Abraham Elgart to inform this court of any claim that the imposition of identical discipline in the state would be unwarranted. Jonathan Abraham Elgart did not file a response. The court having reviewed the file in this matter has unanimously determined that the following order should be entered. Now, therefore, it is hereby

ORDERED:

The Washington State Supreme Court does hereby reciprocate discipline in the State of Washington and orders that Jonathan Abraham Elgart is disbarred from the practice of law. Pursuant to ELC 13.2 the effective date of disbarment is seven days from the date of this order.
