Turner with misconduct as 20 set forth therein. 21 Under ELC 10.6(a)(4), the Hearing Officer finds that each of the factual 22 allegations set forth in the Formal Complaint is admitted and established. The Formal 23 Complaint is attached as Appendix A and incorporated herein by reference.

8	Officer recommends that Respondent Harold M. Turner be suspended for a period of six

10	owing in the 2008 admonition proceeding, 08#00016, and in this proceeding, including interest.
