DISCIPLINARY BOARD ORDER ADOPTING HEARING OFFICER'S DECISION

This matter came before the Disciplinary Board at its March 2, 2018 meeting on Respondent's appeal of Hearing Officer David B. Condon's Findings of Fact and Conclusions of Law and Recommendation. The Hearing Officer recommended disbarment following a hearing and Respondent appealed. On June 12, 2017, Respondent requested oral argument before the Board. On January 18, 2018, WSBA served Respondent with an order setting oral argument for March 2, 2018 at 9:30 a.m. Respondent did not appear for the oral argument.

The Board reviewed the full record in this matter, including the record of the supplemental proceeding and the Hearing Officer's December 11, 2017 Order Denying Motion to Continue Supplemental Proceeding, Striking Supplemental Proceeding and Returning Matter Back to the Disciplinary Board.
